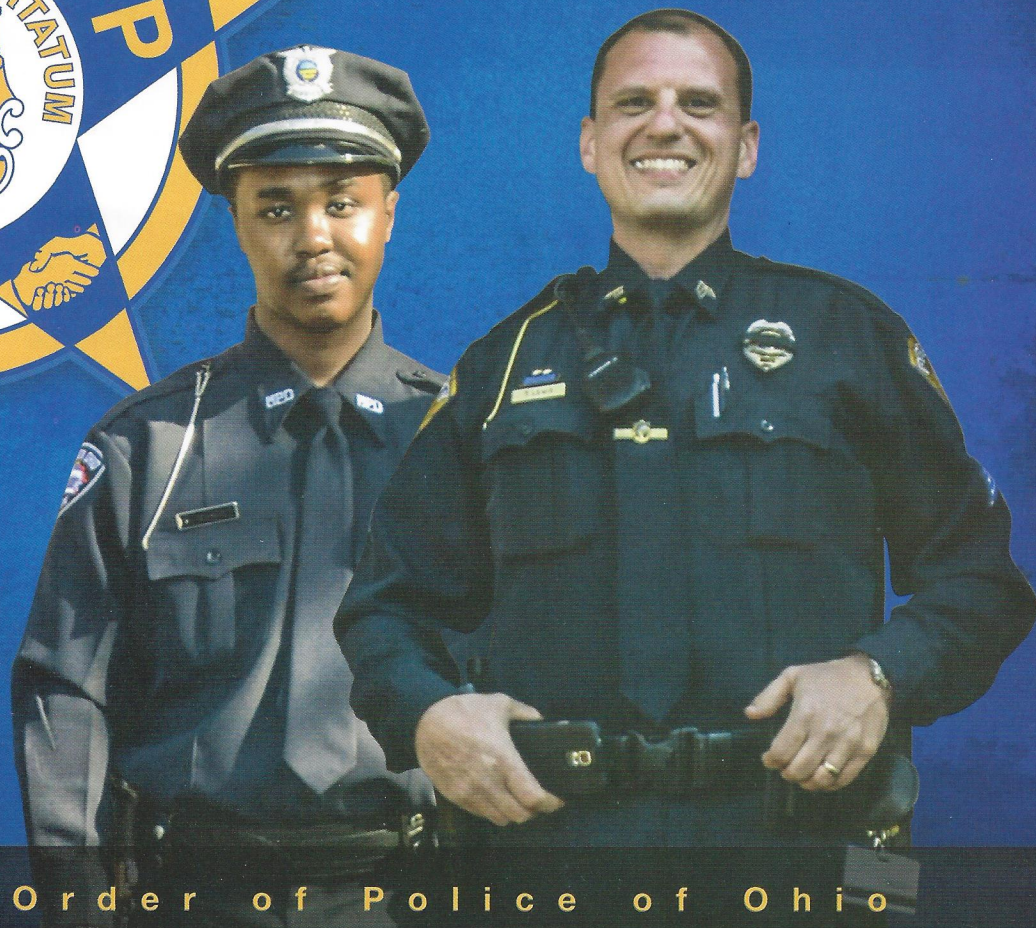
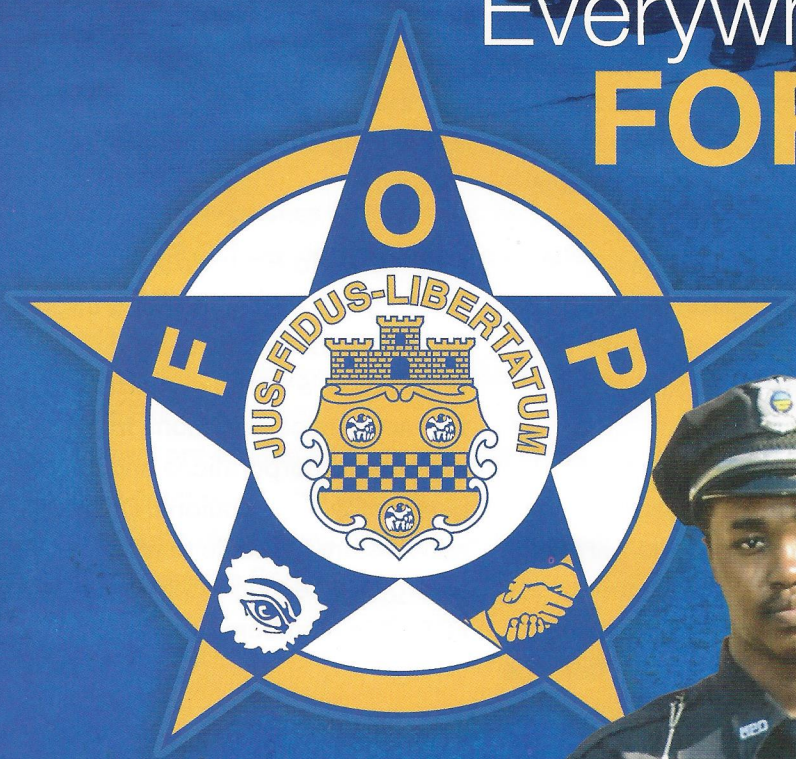

Legislative Services

The Fraternal Order of Police is the largest and most influential law enforcement organization lobbying in the Statehouse and on Capitol Hill, for issues important to rank and file officers. From leading the fight against Senate Bill 5; to protecting pensions; to protecting our safety on and off the job, the Ohio Fraternal Order of Police has led the way.

Honoring our Heroes

The FOP recognizes that we must always fight to remember the sacrifice made by those killed in the line of duty. The National Peace Officers' Memorial Service on the lawn of the United States Capitol is a solemn event to honor those who have given their lives in service to their community. In Ohio, the FOP purchases a United States Flag to be flown at the Ohio Peace Officers' Memorial service to honor each Ohioan killed in the line of duty.

Education Services

The Fraternal Order of Police knows that our members value training and education. The FOP of Ohio offers many training sessions on labor and other issues throughout the year. The National FOP also provides numerous training seminars to make our members more educated at the contract table and also with skills to enhance their career. Included in these programs is the NATIONAL FRATERNAL ORDER OF POLICE UNIVERSITY. The FOP recognizes that college



degrees are increasingly important to our members, the FOP collaborates with a consortium of colleges and universities to offer member discounts on tuition.

Member Benefits

The FOP provides a myriad of services to our members as a benefit for belonging to the organization, like our legal defense plan, to discounted home and auto insurance, to financial products to college scholarships and many more. Every member of the FOP of Ohio is entitled to a \$3,500 accidental death policy and a \$5,000 killed in the line of duty benefit.

Communication

Every member will receive the FOP Journal, the official magazine of the FOP four times a year. You will also get regular email updates about legislative and other priorities and a regular electronic newsletter from the FOP. The FOP also uses Facebook pages and Twitter accounts to inform members.

Charity Partnerships

The Law Enforcement Torch Run for Special Olympics and Easter Seals are the designated charities of the Fraternal Order of Police. Many local lodges and members

dedicate a significant amount of time and resources to these two charities and they have built a lot of goodwill towards our profession as a result.

Critical Incident Response Service (CIRS)

Established in 2002, the Critical Incident Response Service provides peer counseling to law enforcement and their families who confront life-threatening circumstances in the line of duty.

FOP of Ohio Foundation

Funding for CIRS is provided through grants and donations to FOP of Ohio Foundation, a 501c3 organization that accepts contributions from individuals, corporations and community organizations. CIRS services are available to all emergency service workers, not just FOP Ohio members.

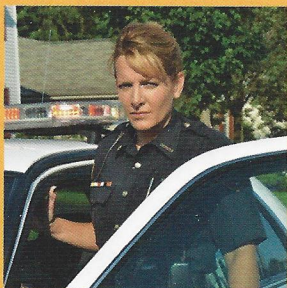


Fraternal Order of Police Ohio Labor Council

In 1984, the innovative leadership of the Fraternal Order of Police of Ohio realized that with the implementation of public sector collective bargaining, there would be an immediate need for individuals skilled in negotiating collective bargaining agreements for law enforcement throughout the state.

- The OLCI represents more law enforcement personnel in Ohio than any other union.
- Full time exclusive, experienced Staff provide the negotiating and servicing of Labor Agreements.
- A full time Legal Staff is available to handle legal issues that arise.
- Members are covered at no additional cost for Administrative, Civil and Criminal incidents that arise from your employment whether on or off duty.
- Members are provided assistance with questions concerning FLSA, ADA, FMLA, Pensions, Unemployment and Workers Compensation.
- Members have access to Attorneys 24/7.
- The FOP/OLCI full time Administrative Staff answers to a 7 member Executive Board elected by you.
- All members are eligible to be elected to a seat on the Executive Board.
- Members are eligible to be a delegate at the annual conference and vote on dues, changes to the Code of Regulations, vote for members of the Executive Committee.

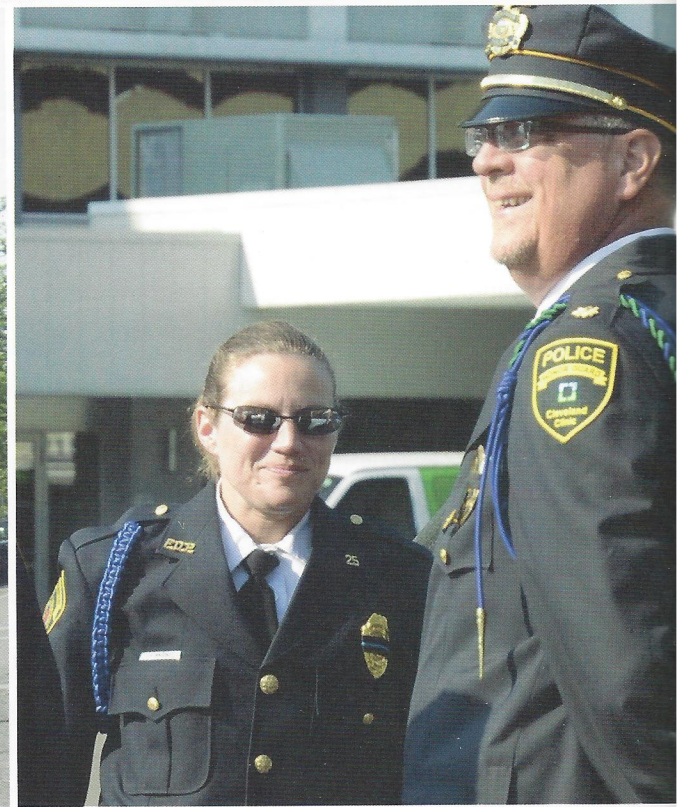


Advocating for you!
