

### History of Daylight Saving Time - DST

Today, <u>Daylight Saving Time</u> (DST) is used to save energy and make better use of daylight. The idea has been suggested in ancient times and later by famous scientists.

Clocks are set ahead one hour when DST starts. This means that the sunrise and sunset will be one hour later, on the clock, than the day before.

#### Ancient Civilizations

Although DST has only been used for about 100 years, the idea was conceived many years before. Ancient civilizations are known to have engaged in a practice similar to modern DST where they would adjust their daily schedules to the Sun's schedule. For example, the Roman water clocks used different scales for different months of the year.

### Benjamin Franklin

American inventor and politician Benjamin Franklin wrote an essay called "An Economical Project for Diminishing the Cost of Light" to the editor of *The Journal of Paris* in 1784. In the essay, he suggested, although jokingly, that Parisians could economize candle usage by getting people out of bed earlier in the morning, making use of the natural morning light instead.

#### (D). A POLICE AND FIRE CHANGE OF OCCUPATION COMPENSATION AWARD

If a firefighter or police officer has contracted a cardiovascular and pulmonary disease as defined in division (W) of section 4123.68 of the Revised Code and a change of the firefighter's or police officer's occupation is medically advisable in order to substantially decrease further exposure to smoke, toxic gases, chemical fumes, and other toxic vapors, a change of occupation award may be made.

#### ATTEMPTS TO CHANGE THE LAW

The law's exclusion of mental conditions has been criticized (See Appendix, pp. 1-2), and Senate Bill 252, currently pending in the General Assembly, would allow for PTSD of peace officers and firefighters to be compensable.

# 1. RECEIVED IN THE COURSE OF, AND ARISING OUT OF, THE INJURED EMPLOYEE'S EMPLOYMENT

#### (A). SPECIAL DUTY

State, ex rel. Village of Oakwood, v. Industrial Commission of Ohio (2012), 132 Ohio St.3d 406, 2012-Ohio-320

\* Village of Oakwood police officer working special duty at a highway construction site.

\* In uniform.

- \* Paid by the construction company.
- \* In a village cruiser (being leased by the construction company).
- \* Injured when another vehicle hits the cruiser.

\* Issue: Which entity was the employer, the Village or the construction company? The Industrial Commission ruled the Village was the employer.

\* Ruling: Ohio Supreme Court defers to the expertise of the OIC and finds no abuse of discretion in its holding that the Village was the employer.

Dayton v. Cooper (1997), 120 Ohio App. 3d 34

- \* Dayton police officer, working as a loss prevention specialist at a grocery store.
- \* Out of uniform, off-duty.
- \* Paid by an independent contractor, not by the City.
- \* Injured while trying to arrest a shoplifter.

\* Ruling: Because he was exercising his arrest powers as a police officer, he was considered an employee of the City when he was injured.

#### NATIONAL FOP OFFICER ALERT

The next time you arrest a suspect carrying a cell phone, take a closer look—and be careful how you handle it.

In the past few weeks, guns made to resemble a mobile phone have begun to surface in various European countries, and they are sure to make the journey across the Atlantic before long. In fact, the Street Survival Newsline has received reliable information from The Netherlands that the mobile-phone guns will be in the U.S. soon.



According to an article in the London Times on October 28, 2000, a special unit of the Dutch police seized eight "mobile phone guns" during raids on five Amsterdam addresses. It appears that these weapons are mainly intended for close-range shooting, as a simple push of a button on the keypad can fire a 22caliber round, and this improvised weapon can hold up to four rounds.

Although it will NOT operate as a real cell phone, Newsline was told that "the phone will light up when a button is pushed, giving the illusion that it is a functioning device."

The black cell phone guns that have been spotted thus far are approximately 14cm tall (including the antenna) and 5cm wide, with 13 black numerical push buttons, two red buttons and a green light-up display. The top portion of the cell phone gun has four barrels capable of shooting four .22 short caliber rounds, with the fourth barrel being disguised as an antenna.

The gun is cocked using a bar located in the lower part of the device. After the gun is cocked, four of the buttons will function as triggers.

Amsterdam police spokesman Cees Rameau told a reporter for the London Times, "If you didn't know [the cell phones] were guns, you wouldn't suspect anything."

The Dutch police confirmed that most of the weapons recently seized came from Yugoslavia, although they didn't know for whom the weapons were intended. Of the six suspects arrested, two were from Yugoslavia, one was from Croatia, and another was from Turkey.

**EXAMPLE 1** You put your lives on the line for Ohioans' safety every day.

As public safety professionals, I want to be sure you know your rights under the law to protect your personal information and families, while preserving your right to participate in Ohio elections.

Ohio law provides that **peace officers, parole officers, probation officers, bailiffs, prosecuting attorneys, assistant prosecuting attorneys, correctional employees, youth services employees, firefighters, EMTs, or investigators of the Bureau of Criminal Identification and Investigation** may redact their home addresses from public databases, including Ohio's online voter rolls. THE FOLLOWING IS A DIRECT RESULT OF THE UC OFFICER SHOOTING AND SUBSEQUENT PROSECUTORS STATEMENT:

"The Fraternal Order of Police of Ohio was disappointed by Hamilton County Prosecutor Joe Deters' remarks that disparaged all of the officers of the University of Cincinnati Police Department. These professional officers are dedicated to protecting their community and work tirelessly to do so. University police are certified state peace officers and they do their job with honor and distinction just as city police, county sheriff deputies, and other law enforcement professionals do.

Prosecutor Deters also referred to enforcing Ohio's vehicle laws as "chicken crap." Ohio's legislature has determined that every vehicle must have a front license plate and thirty-four other States have the same law. Ohio's law enforcement officers have found enforcing the front license plate law to be invaluable in solving crimes, ranging from robberies and murders. Fleeing felons, wanted fugitives, even terrorists have been caught because of traffic stops for minor vehicle code violations.

We understand that politicians often make statements meant for political impact and aimed at public opinion. That appears to be what this prosecutor was doing. But his remarks should not have disparaged all university police or the thousands of officers who follow the law by conducting traffic stops for minor misdemeanor violations."

# Open government group surveys police camera plans nationwide

With more and more cities across the U.S. issuing body-worn cameras to their police forces, a Washington, D.C. open government group has compiled a reference sheet of state and local government guidelines for their use.

The guide, compiled by the D.C. Open Government Coalition, provides details on policies in all 50 states and 15 major cities that have adopted the technology in the name of greater police accountability. It includes when officers should activate the cameras, how departments are required to store video, and what policies govern the release of footage to the public.

The information posted is accurate as of June 12 of this year. The group posted its findings online in a Github format and said it welcomes updates from outsiders.

"The Coalition is hopeful that its work will be helpful to state and local legislators seeking to understand the choices their peers across the country have made and spurring those legislators to action," the group wrote in a summary of the project. "More importantly, the Coalition is hopeful that this work will energize transparency advocates across the country to understand not just what the law is, but what it could be."

Cities are out front in setting policies for body camera use, the group found, because they have been eager to adopt the tool more rapidly than state legislators have been able to address the issue. Of the 15 cities it surveyed, 12 have implemented pilot programs testing body camera systems, while five have approved the purchase of at least 500 cameras. Of those examined, only Boston has refused to consider the technology.

"While the majority of cities with clearly defined policies prohibit recording interviews with sexual assault and domestic violence victims, or in areas with an expectation of privacy, the

overwhelming response has been to err on the side of recording more, rather than less, police-citizen interaction," the coalition concluded.

This work originated from preparations that the organization made with its lawyers to testify in May against a proposal to exempt body-worn camera video from Washington's Freedom of Information statute. Mayor Muriel E. Bowser made such an exemption a condition of distributing the cameras to the city's 2,400 officers. The city council refused to fund the program with the exemption in place.

#### OHIO FOP NEWS

The Ohio Fraternal Order of Police is grateful for the decision of the Ohio Supreme Court today in Ohio v. Officer Thomas Caine White.

In this decision, the Court ruled Ohio's firearm specification statute which imposes a mandatory three-year prison term for criminal offenses committed using a firearm, does not apply to police officers acting in the line of duty and said:

"The purpose of the firearm specification is to enhance the punishment of criminals who voluntarily introduce a firearm while committing an offense and to deter criminals from using firearms. In enacting firearm specifications, the General Assembly recognized that "a criminal with a gun is both more dangerous and harder to apprehend than one without a gun." . . . But in contrast to those who freely choose to use a firearm while committing a crime, a firearm specification is not intended to deter a peace officer from possessing a firearm, because the officer is required to carry a firearm and permitted to use it, when necessary, in the course of carrying out the duties of a law enforcement officer."

#### Social Security Fairness Act" Introduced in Senate!!!

06/26/2015

Chuck Canterbury, National President of the Fraternal Order of Police, welcomed the introduction of S.1651 the "Social Security Fairness Act," in the United States Senate.

"The FOP has been pushing for this repeal for many years," Canterbury said. "We are very pleased that Senators Brown and Collins are again leading the charge to repeal the WEP and GPO."

This bill was introduced by Senators Sherrod C. Brown (D-OH) and Susan M. Collins (R-ME). The legislation would repeal both the Windfall Elimination Provision (WEP) and the Government Pension Offset (GPO) in current Social Security law.

The Windfall Elimination Provision (WEP) affects many workers who have spent time in their jobs not covered by Social Security and have also worked other jobs where they paid Social Security taxes long enough to qualify for retirement benefits. The provision has a disproportionate effect on those in law enforcement, as these officers are often forced to retire earlier than other public employees and are more likely to begin a second career after they leave law enforcement. Officers in this position are penalized and may have their Social Security benefit reduced up to 60%.

"The WEP substantially reduces a benefit that workers had included and counted on when planning their retirement and it substantially penalizes lower paid public employees with short careers or, like many retired law enforcement officers, those whose careers are evenly split inside and outside the Social Security system," Canterbury explained. "This is a loss of benefits to which they are entitled, not an adjustment for a 'windfall.'"

Like the WEP, the GPO was adopted in 1983 to shore up the finances of the Social Security Trust Fund. It offsets the dependent's Social Security benefit to which a spouse or widow(er) is entitled by two-thirds of the monthly amount of any government pension from non-covered employment that the surviving spouse might receive.

"Nine times out of ten this so-called 'offset' complexity eliminates the spousal survivor benefit even though they earned the right to the benefits," Canterbury said.

"The WEP and GPO Provisions will not eliminate a windfall for workers; instead they have proved to be a windfall for the Federal government at

the very expense of public employees. That's not right and it's not fair," Canterbury said "Congress should repeal these inequitable provisions and pass the 'Social Security Fairness Act.'"

The House companion bill is H.R. 973.

Capped by an interim report by the president's task force on 21st century policing which listed dozens of recommendations and action items pointed solely at perceived failings within law enforcement. Of course there are very real concerns about policing especially as in requard the delicate balance between respect for our citizenry and the necessity of performing certain actions in the line of duty. But the vast majority of law enforcement personnel are committed to a life of service that commonly demand too much while paying too little. For more then 20 years the non-profit law enforcement legal defense fund has been rising to the defense of officers like Darren Wilson. The fund recognizes the harm that can come to well-intended officers who are put into incredibly difficult circumstances by virtue of the oath they take that harm can be financial, emotional and professional. It ends promising and productive careers an can result in convictions for homicide, manslaughter or other felonies.

#### PREPARE FOR THE HEAT!

Last Year had 10 days over 100 degrees The department of health issues Heat advisory information during those hot days which help us to stay well.

- 1. Drink lots of WATER Not soda, caffeine drinks or alcohol
- 2. Wear light colors if possible, light weight clothes and for on duty wear the underarmour that wicks moisture and heat from your body.
- Keep your hat on in the sun removing it occasionally to release heat. Your brain does not operate well if you're over heated.
- 4. Wipe your vest down to remove body sweat which contains salt from your perspiration. This will help keep the integrity of the material.
- 5. Use SPF30 sunscreen especially on your face. Most skin cancer is caused by sun exposure.
- 6. Getting in and out of your air condition car can really take a toll on your body so try to keep windows open with a/c on to keep a better balance on your body temperature.
- 7. If working out or doing manual labor take frequent breaks and remember to hydrate
- 8. Placing a wet towel or commercial cool band around your neck also helps keep the blood flowing to your head cool.
- 9. If you feel extremely hot dry your skin is red seek medical help these are signs of Heat Stroke.



### FINGER PRINTS, EYE PRINTS AND NOW


#### **SHOE PRINTS**

Here is another technology that is going to make "perfect <u>crime</u>" something that happens only in fiction. Researchers in UK have made an automated system that compares features on shoe soles of suspects with those of the shoe prints left behind at the crime scene. Since shoe prints are something that criminals often leave behind, a UK act gives this forensic evidence the same legal validity as DNA and fingerprints.

Shoe prints have been used in the past as evidence but it involved human analysis and interpretation. The new technology uses image processing to find out about the sole's features like logos, circles or ridges. The results are compared with the prints taken in custody suites for a possible match.

### **State FOP News**

During the last state meeting past president Dewey Stokes referred to his appointment to the board at the Bureau of Workers Compensation. He advised us of a financial opportunity for our department officials to take advantage. The BWC has voted 15 Million Dollars for a grant program for Accident and injury prevention. Fire Departments, Nursing Homes, and a School District just collected large amounts of money for lift accidents and back injury prevention. Electric lifts for cots, in ambulances lifts for patients, light weight tables in school cafeteria to prevent back injuries in liftig heavy objects. The money is there. Think outside the box and see what you can purchase to decrease injury, accidents. Police Officers have just as many on duty injuries as firemen and nurses. Let's take advantage of this financial opportunity in purchasing equipment that can prevent officer accidents and injuries. Special work gloves to prevent hand injuries. Special equipment for sight, hearing, and even shoes for foot injuries? Check out BWC safety and wellness grants. For every 1 dollar they give you 3 dollars.

The second item that was found interesting was the Death benefit for auxiliary or volunteer police officers. The FOP got Senate Bill 288 introduced and it passed the Senate. If it does not pass the House in the lame duck session we will need to start over. We have a letter which you can used as a template to send to your state representative that says pass SB288 in lame duck session. Please know this is important to the FOP, and all Law Enforcement members full or part-time.

Senate bill 252 is being supported to correct a Supreme Court ruling that says in order for an officer to receive disability for PTSD he/she must also suffer a physical injury. Senator Tom Patton Submitted a bill to correct this and that states PTSD for first responder will be covered by BWC. The Senate has passed this and it is going to the House. Please pass this on to your families to write the state reps to pass this bill.

#### **REQUEST FOR LEGAL COUNSEL**

Section 6.a Any lodge member in good standing is entitled to purchase insurance coverage through the Fraternal Order of Police Legal Plan, Inc. The FOP legal Plan is designed to provide for payment of legal defense costs for covered administrative, civil or criminal actions taken against a law enforcement officer. Detail of the plan requires the insured to pay a deductible charge or use of the FOP legal plan may apply for reimbursement of the deductible amount paid (to \$250.00) one time per year.

Section 6.b The board will advise the membership of any approval or denial of a member's request of reimbursement.

Section 6.c The member is responsible for advising the board of the progress concerning the action.

Section 6.d The lodge shall not pay any part of a monetary judgment in the event a member loses his/her suit and a monetary judgment is rendered against him/her and is upheld.

Section 6.e Any active working member who is a member of the Ohio Labor Council(OLC) who is involved in a labor dispute or action from the police department will contact his/her union representative and the OLC first. IF the OLC assigns legal counsel the OLC will contact an attorney to respond.

Section 6.f The lodge attorney will make himself available to answer quest5ons that a member might have, but any expense incurred will be paid by the member and not the lodge.

#### Blue Alert and BVP Bills Pass Senate Committee!!!

03/26/2015

Chuck Canterbury, National President of the Fraternal Order of Police, welcomed news that the Senate Committee on the Judiciary considered and favorably reported S. 125, the "Bulletproof Vest Partnership (BVP) Grant Program Reauthorization Act," and S. 665, the "Rafael Ramos and Wenjian Liu National Blue Alert Act," by voice vote.

"These two bills are key pieces of the FOP's Officer Safety Agenda, which we outlined earlier this year, and we're so grateful to Senator Leahy for all of his work on both bills, but especially the BVP," Canterbury said. "And of course, we sincerely appreciate Chairman Grassley's making good on his word to move these bills early in the year. Without his efforts, it was likely both bills would have been pushed off until next month."

The Bulletproof Vest Partnership (BVP) grant program provides matching Federal funds to State and local law enforcement agencies allowing them to purchase or upgrade the soft body armor worn by their officers. More than one million vests have been bought through this program, which has greatly increased the safety of officers on the beat. The legislation favorably reported by the Committee today would reauthorize the program through 2020.

The "Rafael Ramos and Wenjian Liu National Blue Alert Act," would provide for local, regional, and national dissemination of time sensitive information that would help apprehend a suspect accused of killing, kidnapping, seriously wounding, or who may pose an imminent and credible threat to a law enforcement officer.

The Interim Report of the President's Task Force on 21st Century Policing recommended the establishment of a National Blue Alert System and the reauthorization of the BVP program.

The Committee considered both bills on a single vote and four Senators requested that their vote be recorded as "Nay." They are: Senators Jeffry L. Flake (R-AZ), Michael S. Lee (R-UT), David A. Perdue (R-GA) and Jefferson B. Sessions III (R-AL).
